


that there are Well over a million families in New Zealand? And in Hawke's Bay, there were 40,965 families at last count.


Hawke's Bay families: A snapshot

Hawke's Bay family members – along with most of those in the rest of New Zealand – were likely to report being treated fairly and having easy access to services. Hawke's Bay family members were notable, however, for having strong connections with their families and communities, scoring the highest in the country for providing support to extended family, and having the right level of contact with them. Compared to members from similar types of families, they were the least likely to feel safe at night in their neighbourhoods or to be OK with their working hours and pay. Hawke's Bay families also have a lower likelihood of living in well-off areas.



About the Families and Whānau Status Reports

Each year since 2013, we have produced an annual families status report that measures and monitors the wellbeing of New Zealand families and whānau. This requirement was introduced by the Families Commission Amendment Act 2014, and we are proud to undertake this work.

The general aim of the Families and Whānau Wellbeing Research Programme is to increase the evidence about family and whānau wellbeing. Our research aims to better understand how families and whānau are faring, and the key role they play in society. This is so that decision-makers in the social sector make informed decisions about social policies and programmes and better understand what works, when and for whom.
